2	<p>Collusion Clause</p> <p>The Board reaffirmed its commitment to adhere to the Collusion Clause.</p>
3	<p>Approval of Minutes</p> <p><i>MOTION: It was moved by D. McClure, seconded by B. Gooderham that the Minutes of the February 10, 2021, Board meeting be approved. Carried.</i></p>
4	<p>Executive Reports</p> <p>(a) President's Report</p> <ul style="list-style-type: none"> • A series of meetings with City Councillors have been arranged for March and April, and we would like to ask Board members to participate. • Our Education Series is underway, we have held our first two events. • Sandro Ricci will join us to provide an update on the Excess Soil presentation at the Education Series on March 4, 2021. <p>(b) Treasurer's Report</p> <ul style="list-style-type: none"> • The Treasurer's Report shows our revenue and expenses up to the end of February. • As of this week, we have received approximately \$95,000 in membership dues, which is 115 renewals. Last year we had 102 renewals by the end of February, so we are on track. • We applied for the Canada Emergency Wage Subsidy for August to December and received and received 13,706.04. Total CEWS received for 2020 is \$38,273.04. We will continue to monitor our eligibility and submit further applications as they become due. <p>February 2021 Expenses</p> <p><i>MOTION: It was moved by N. Bray, seconded by S. McEachen THAT the February 2021 expenses be approved. Carried.</i></p>
5	<p>City of Ottawa</p> <p>(a) City Council Motion regarding social procurement</p> <p>In February, City Council passed a motion regarding social procurement.</p> <p>NCHCA met with the City on Friday to get a better understanding of what the implications are for industry, but the concept is very vague so far.</p> <p>(b) City decision on new 127 rates & warranty periods</p> <p>Re 127 Rates: the City has confirmed that it will pay 85% of the new 127 rates with a 15% markup.</p> <p>Re Warranty Periods: the City has confirm that it will not be making a change with regards to warranty requirements and the standard for City contracts will remain at 2 years.</p>

	<p>(c) City decision on OHSMS requirements for contractors</p> <p>NCHCA met with the City on February 17, 2021 to review the timelines for the City's requirement that contractors wishing to do work for the City have an acceptable HSMS in place in accordance with the timelines set out in the January 2020 technical bulletin.</p> <p>The City has confirmed that it will not change the timelines.</p> <p>NCHCA, OCA and CLAEO are hosting a joint webinar on the 3 acceptable systems on March 30, 2021. The webinar will be a panel discussion moderated by Neil Falls with representatives from Aecon, Tomlinson, Marathon and PCL.</p> <p>(d) City Staff Memo to Council re Supply Chain Shortages</p> <p>A City staff memo to Council based on a letter from OCA regarding current and anticipated supply chain shortages was provided to the Board. The memo indicated the following shortages:</p> <ul style="list-style-type: none"> • Increased prices since the pandemic, from 10% to 40% to date for steel, sheet metal and several other commodities, with these increases expected to last for the next six months or more; • Difficulty obtaining some materials, causing schedule delays; • Shortage of skilled labourers in many sectors; and • Significant cost increases for insurance policy renewals. <p>We are also aware of a significant increase in the cost of pipe.</p> <p>(e) Liaison Meeting Notes February 19, 2021</p> <p>Item 6 – the discussion as to whether contractors could do cappings and connections was closed by Bruce Kenny with the comment that the City “will not be considering these suggestions at this time”, however industry could put forward documentation as to how this would benefit projects and the City. This will be further considered by NCHCA’s sewer and watermain committee to develop a business case.</p> <p>Item 7 – the suggestion for watermain isolation plans was also closed by the City as being unnecessary as a valve has never failed in the City. The City has no internal policy on this.</p> <p>(f) The March 5, 2021 Forecasted Tender List was provided to the Board. NCHCA has asked the City that a 12-month FTL be provided.</p> <p>(g) The next Liaison Meeting will be held March 19, 2021. Please let K. Sutherland know if you have any items to add to the agenda.</p> <p>(h) NCHCA meetings with City councillors</p> <p>A series of meetings have been set up with City Councillors in March and April. Please let K. Sutherland know if you are interested and available to attend. Speaking notes will be provided.</p>

Tomlinson Limited • Sandro Ricci, ASL • Kyle Peori, Clean Water Works Inc. <p>In considering the Board Nominating Policy, the size and composition of the Board, and the expressions of interest received, the Nominating Committee will recommend to the Members for approval at the AGM that Sandro Ricci and Kyle Peori be approved as Directors for a 3-year term commencing April 2021.</p> <p>Leon Switzer has decided to step down from the Board to focus on his career. S.
